BY-LAWS OF THE  
BOARD OF LAW LIBRARY TRUSTEES OF RIVERSIDE COUNTY

(January 24, 1969)

ARTICLE I – NAME, NATURE AND PURPOSE

The name of this organization is “Board of Law Library Trustees of Riverside County,” herein called “Board.” It is a local public agency existing and functioning pursuant to Chapter 5 of Division 3, Sections 6300 et seq. of the Business & Professions Code of the State of California. The Board is to govern the Law Library established for the County of Riverside, in accordance with said provisions of law.

ARTICLE II – MEMBERS

There are seven members of the Board, consisting of five judges of the Superior Court, or their designees, the Chairman of the Board of Supervisors, or his/her designee, and one member of the State Bar, appointed by the Board of Supervisors, whose principal office is located in the County of Riverside. All

members serve without salary or other compensation for a term of one year, commencing on February 1 after their appointment,

### ARTICLE III – OFFICERS

The officers shall be a President, who shall be a member of the Board and a Secretary, who may be either a member of the Board or the Law Librarian. The Board may choose a Vice-President who shall be a member of the Board. The Board shall choose its officers at the regularly scheduled meeting in February of each year to serve during the ensuing twelve month period, and may fill a vacancy in office at any regular meeting.

### ARTICLE IV – MEETINGS

Regular meetings of the Board shall be held on the ~~first~~second Friday of each month

at 12:00 noon at such place as the President shall designate. Meetings of the Board shall be open to the public and shall be called and conducted in accordance with the Ralph M. Brown Act, Section 54950, et seq. of the Government Code of the State of California.

Four members shall constitute a quorum for business and an affirmative vote of the majority of all members present are required to exercise the powers of the Board.

Meetings shall be conducted in accordance with usual parliamentary practices,

subject to the control of the Board.

#### ARTICLE V – POWERS

The Board shall have and exercise the powers conferred by the above-mentioned statutes and other applicable provisions of the Constitution and laws of California.

The Board may adopt, and from time to time amend, rules and regulations for the operation of the Law Library and any branch thereof.

The Law Library shall be maintained at the City of Riverside and at such other branches authorized by the Board.

#### ARTICLE VI – AMENDMENT

These by-laws may be amended at any regular meeting of the Board with ten written days notice by the Secretary to the public and all Board members.
