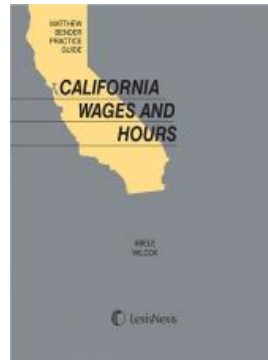
"Obscenity, Books, and Libraries"

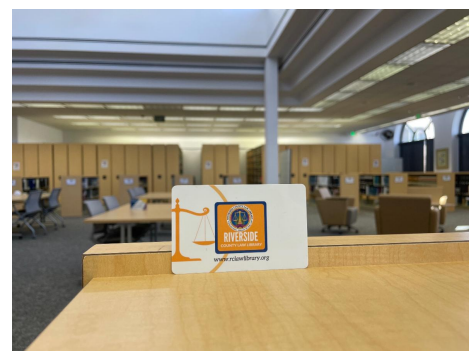
