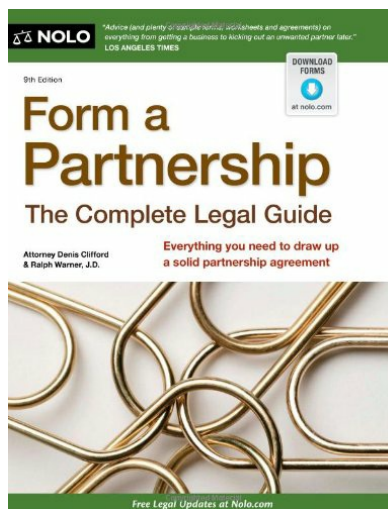
"California Wildfires: Resource Links for Recovery and Insurance Claims"

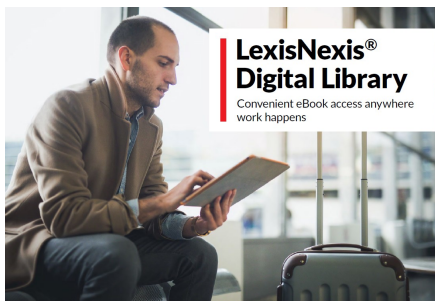

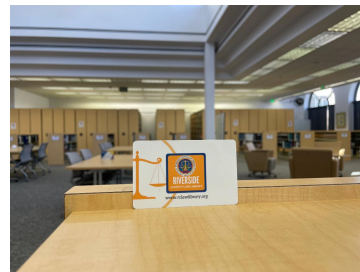

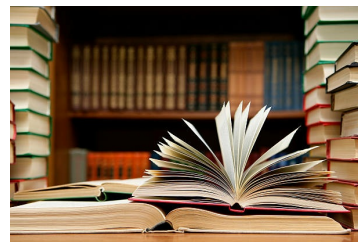
