

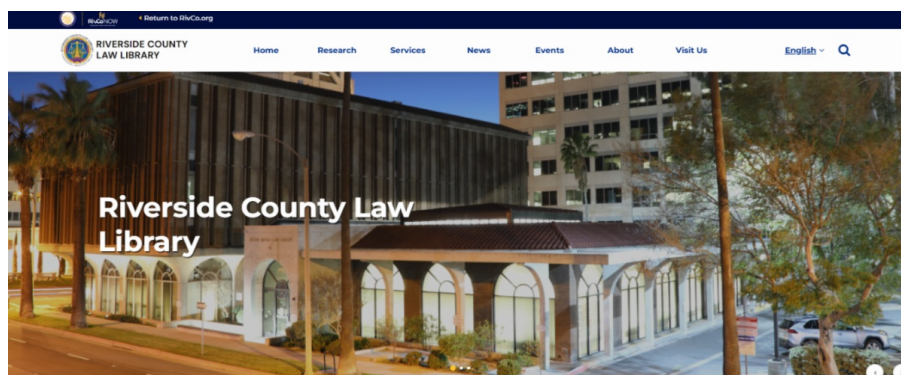

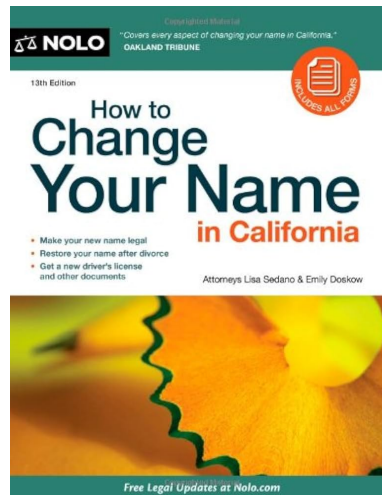
"The Meaning of California's New State Symbols"

AB 1797, principally authored by Assembly-member Jim Wood, appoints the Dungeness crab as California's state crustacean. 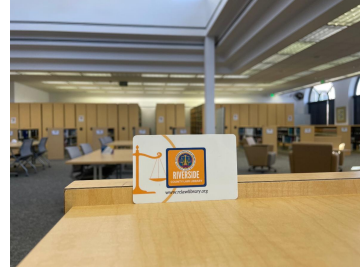

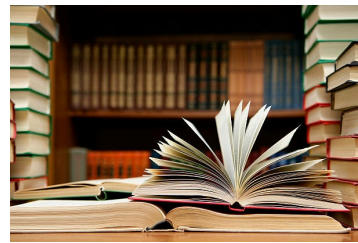
