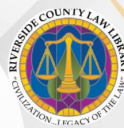

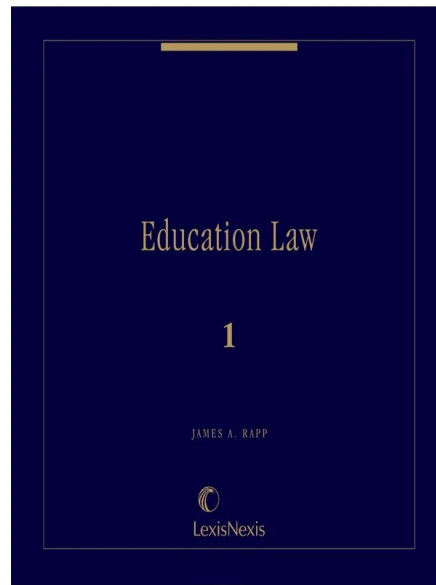


"Law Librarian Insights: Google First, Use Booleans Later"

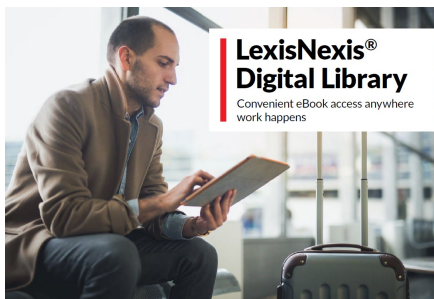

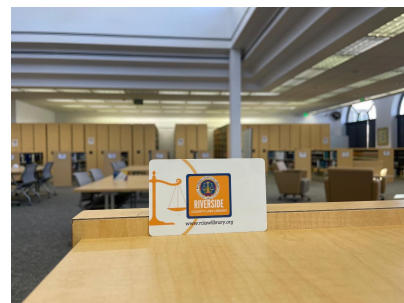
