

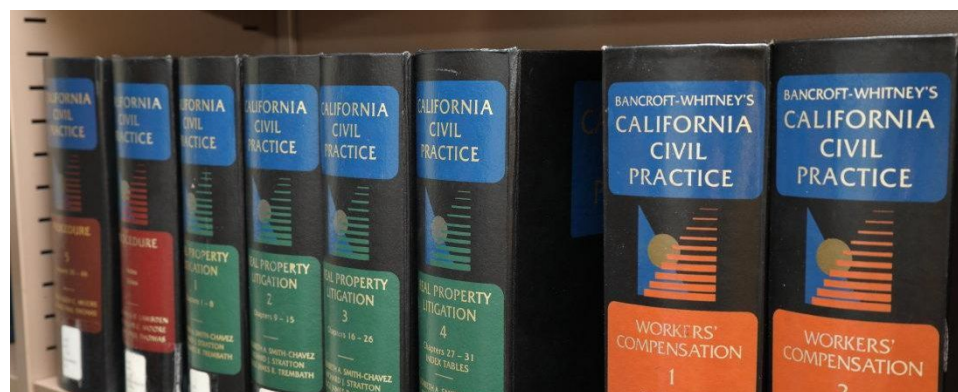

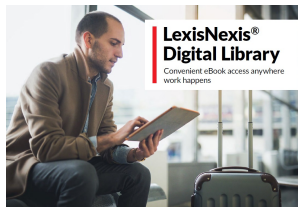


Updated RCLL Research Guides!
