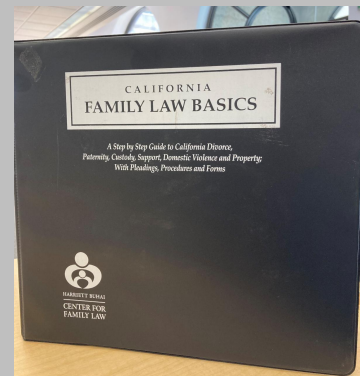

This is the ideal legal book for self-represented litigants who need step-by-step instructions for filling out their family law judicial council forms and pleadings. It's twenty-five chapters are tabbed with each titled for a specific subject and form, going in-depth for certain family codes and why a form is needed. It is targeted for low-income or working-class people and parties with children. For divorce cases, it provides the forms with samples and how to draft declarations, pleadings, and correspondence for different scenarios.
