### 2022 Riverside County Elder and Dependent Adult Abuse Symposium

On June 1, 2022, RCLL Librarians Jenna and Andy went to the Symposium at the Riverside Convention center. The event featured speakers from Riverside County, San Diego County, and other service providers in the Southern California area. They discussed elder scams taking place over the phone and internet all over the county. Such as the grandma/grandpa scam, bank account scams, social security scams, and more. There was also a panel of speakers from offices in Riverside County discussing the difficulties facing seniors today such as Medicare, isolation, and health.

We spoke to 87 people about our services. Most were very surprised that there was a law library in the area and



were excited to hear about our databases, MCLE classes, and NOLO books.

In the future, we hope to attend again and feature more of our services. We came back with several takeaways on what we can do to better expand access to justice for our seniors and patrons with disabilities.

## Resource Spotlight

### **California Causes of Action (KFC 1003 .C35)**

A great resource for the general public or legal professionals. It is updated every year by James Publishing. Chapters inside are divided into clear categories such as “Real Property Torts,” “Animal Torts,” “Intellectual Property” etc. There are a total of 21 categories covering 125 causes of action. When you find a situation that matches yours such as “Trespassing Livestock Causing Harm,” the book walks you through the elements of the case that must be pleaded, relevant authorities, remedies, statute of limitations, affirmative defenses, and related causes of action. Many also include a sample complaint or pattern that can be followed to draft a specific complaint. CA Causes of Action is available in print at all three RCLL locations.
