Congratulations to our newly-elected Board President John Boyd and Vice President, the Hon. Kira Klatchko!

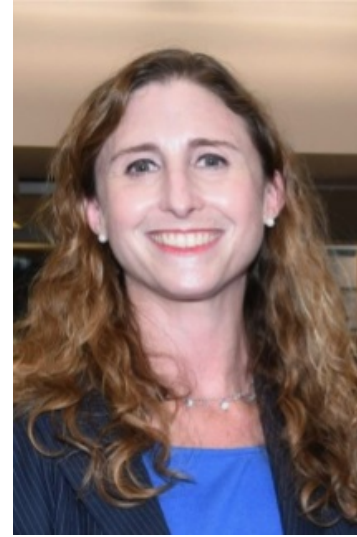

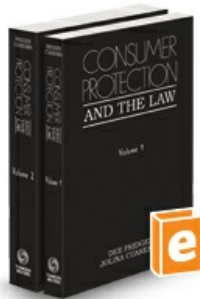

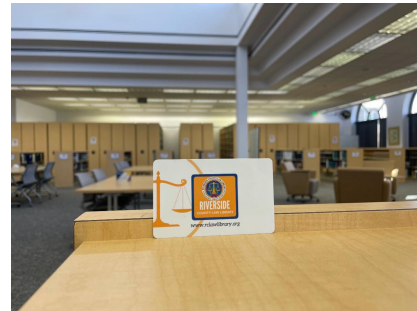
