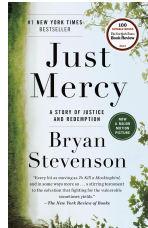

Low-Income Taxpayer Clinic with ICLS

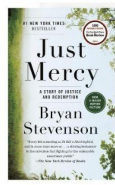
