Hon. Jacqueline C. Jackson elected Vice-President of Law Library Board of Trustees.

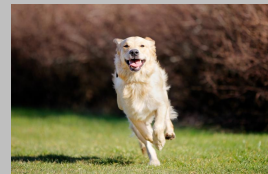
Judge Jackson begins her term as Law Library Board Vice-President this month. She was appointed to the Riverside Superior Court by Governor Arnold Schwarzenegger in 2010. She earned her J.D. from U.C. Hastings College of Law and her B.A. Psychology from UCLA. Prior to joining the bench, she served as deputy district attorney in Riverside and was a former prosecutor in Los Angeles for 10 years.

Judge Jackson brought a strong sense of community service in all the positions she has served. She regularly participated in Project Lead, a program where volunteer attorneys would go into impoverished school classrooms to teach students about the court process and encourage them to stay out of trouble. She taught adults how to read as a volunteer at a local library. She served as a mentor in J.W. North High's Law Academy and as a volunteer judge for mock trials and the youth court. She served on the California Judicial Education and Research Juvenile Law Curriculum Committee (2013-2018) and chaired the committee from 2014 – 2016.
